



INTRODUCTION

Historical Collections & Archives (HCA) is a repository of campus archives, rare books, and medical artifacts on the Health Sciences campus of Augusta University.


To promote HCA, in 2012 the library developed and implemented a History of the Health Sciences Lecture Series. The series educates the University and community at-large about the history of the health sciences by offering quarterly, one-hour lectures held in HCA.

METHODS

Reviewing HCA's current inventory led to collaborative planning to showcase a variety of lectures.

- Local medical historians spoke on topic of their choosing
- Tied lecture to key collections in HCA
 - Manuscript collections
 - Rare books
- Lecture complimented the National Library of Medicine's Traveling Exhibitions
- Lectures on the historical overview of medical fields or procedures such as nursing anesthesia or dialysis

ASSESSMENT


Short survey given at the end of each lecture intended to evaluate the interest level and gain insight to new lecture topics. Questions included:

RESULTS

In the four years of History of the Health Sciences Lecture Series, there has been an increased interest in the content held in HCA as well as historical research opportunities. By rethinking the archives and its importance, the library considers this lecture series a permanent library service.

Data collected: 16 lectures; 366 University and non-University attendees.
